I - Intervention - therapy, diagnostic test, exposure, etc. C - Comparison intervention or comparison of interest. O - Outcome (s) of interest.

Focusing Clinical Questions. A clinical question needs to be directly relevant to the patient or problem at hand and phrased in such a way as to facilitate the search for an answer. PICO makes this process easier. It is a mnemonic for the important parts of a well-built clinical question. It also helps formulate the search strategy by identifying the key concepts that need to be in the article that can answer the question.
